#### Notes for the Short Fiscal Year from August 6 to December 31, 2024

##### I. General Information

The company is a small stock corporation in the form of a European company (Societas Europaea) with its registered office in Munich. It is entered in the commercial register of the Hanover Local Court (Amtsgericht) under HRB 295655. Its sole shareholder is Continental AG, Hanover. The company was incorporated as Blitz 24-891 SE. Amendments to the Articles of Incorporation on February 6, 2025, included a change of name to Continental Automotive Holding SE.

The annual financial statement as at December 31, 2024, was prepared in accordance with the applicable provisions of the German Commercial Code (HGB) for small stock corporations, the EU SE Regulation, the provisions of the SE Implementation Act (SEAG), as well as other regulations specific to the legal form (Sections 150 to 160) of the German Stock Corporation Act (AktG). The income statement was prepared in accordance with Section 275 (3) of the HGB using the nature of expense method. The fiscal year is the calendar year. Due to incorporation during the course of the year, 2024 is a short fiscal year.

##### II. Accounting policies

Receivables and other assets are recognized at nominal values in the balance sheet.

Cash in hand and bank balances are recognized at nominal value.

The provisions are recognized as liabilities at the settlement amount deemed necessary according to sound business judgment and take into account all identifiable risks and contingent liabilities.

The liabilities are recognized at their settlement value.

##### III. Notes on the balance sheet

#### EQUITY AND LIABILITIES

##### Equity

The subscribed capital amounts to €120,000.00, of which €30,000.00 was paid in upon incorporation. On October 22, 2024, the outstanding contribution of EUR 90,000.00 was made. The full amount of the subscribed capital has therefore been paid in.

##### Provisions

The expenses for the annual audit are reported as provisions.

##### Liabilities

The liabilities are exclusively liabilities to affiliated companies and have a remaining term of less than one year.

##### IV. Other Information

#### Consolidated financial statements

The shareholder of Continental Automotive Holding SE is Continental AG, Hanover, which prepares the consolidated financial statements for the smallest group of companies

#### Employees

The company did not employ any staff in the short fiscal year 2024
